For a Lead Driller, this will be an NVQ L2 and a CSCS Land Drilling – Lead Driller card

Note 2.

For a Drilling Support Operative, this will be an NVQ L2 and a CSCS Drilling Support Operative card

2. In addition to the above all **Lead Drillers and Drilling Support Operatives**, engaged in ground investigation, will have undertaken, or will be registered for the **BDA Audit** (or equivalent 3rd party audit scheme [please state scheme]).

Note 1.

BS 22475-2 states that 'all boring and drilling operatives, to include Lead Drillers and Drillers (Drilling Support Operatives) ... <u>shall</u> hold an NVQ in Land Drilling and hold a **valid and current audit card** of competence ... as issued by the British Drilling Association Ltd or an equivalent body in a State of the European Union'.

Note 2.

BS 22475-3 requires the competency of operatives to be verified at regular intervals to ensure ongoing competence.

Note 3.

ICE UK Specification for Ground Investigation 2^{nd} edition states that 'work shall be carried out in accordance with BS 22475-2 and BS 22475-3'.
